

## 2010 GSFL Winter Meeting Dec 7<sup>th</sup> 2009

**Attending:** Pembroke, Bow, Kearsarge, Concord, Monadnock, Hollis, Upper Valley, Gilford, John Stark, Laconia, Hartford

**Not Attending:** Newfound

Agenda:

1. **All State Selection** – 1<sup>st</sup> proposal -Each team would nominate 3 players – all coaches vote for one player from each team. Then 10 additional players will be selected. Players will be listed by Name Number and Team. 2<sup>nd</sup> proposal – Divisional break down based on Playoff finish - 1<sup>st</sup> and 2<sup>nd</sup> get 4 picks (3 all state – 1 Honorable) – 3<sup>rd</sup> get 3 picks (including Hartford) (2 all state – 1 Honorable) – 4<sup>th</sup> and below get 2 picks (1 All State – 1 Honorable) – **motion passed for 2009 ONLY to accept 2nd Proposal**

**For 2010 – Coaches will be required to keep notes on outstanding players for each team. Team #s are the same as 2009 – The organization will nominate and will be compared to the votes. All agree that a Thanksgiving deadline for teams to submit nominations to webmaster/keeper of the notes.**

### 2. **Playoff Procedure Discussion:**

East V West Divisions worked as a scheduling standpoint. For a playoff situation the top 3 teams in the League came from one Division. This prevented an opportunity for the top two teams to play for the Championship. Discussion on how to format the Post Season while not discounting the Regular season.

Proposal – top seed in each division gets bye – In Round 1 2 East plays 3 East and 2 West plays 3 West. In Next round the winner of the East game plays 1 seed in West and the winner of the West game plays 1 seed in East. – **Motion passed**
